The system is expected to be installed and fully operational by Friday 18th March 2022.

All bidders are required to submit 2 references as part their proposal submission.

WLWA and LBH are not obliged to accept the lowest or any offer made; does not bind itself to complete this exercise and will not be liable for any losses or expenses incurred by an applicant as a result of a decision not to proceed. 1. Introduction

West London Waste Authority (WLWA) is a statutory Waste Disposal Authority (WDA), responsible for disposing of waste collected by the London Boroughs of Brent, Ealing, Harrow, Hillingdon, Hounslow and Richmond upon Thames. Approximately 1.7 million people live in this area, which covers 38,000 hectares.

As part of an overall multi-site security and operational improvement programme, there is a need to upgrade/install CCTV at 4 site locations where waste operations are based. These sites are -

- Abbey Road HRRC (Household Reuse & Recycling Centre) and WTS (Waste Transfer Station) – NW10 7TJ
- Transport Avenue WTS TW8 9HF
- Victoria Road WTS HA4 0YS
- Space Waye HRRC TW14 0TH

Abbey Road - This site has a CCTV system that is currently around 15 years old. Upgrade limitations to the current system and the need to increase compliance regarding health & safety, site security, fire prevention and waste material monitoring means that the current CCTV system is not fit for purpose and needs to be replaced.

Transport Avenue & Victoria Road - To improve access, security and operations at both sites, there is also a need to install a CCTV and ANPR system for coverage of the access roads leading to both sites. Both depots are run and operated by WLWA's waste contractor Suez who have their own CCTV system within the sites. There is no existing CCTV coverage or ANPR in place on the access roads at either site.

Space Waye – This site is run and operated by LBH. There is no existing CCTV system on the site except for one external camera linked directly to Hounslow's ARC Control Station. As part of this site's improvement plans, a new CCTV system needs to be added to increase compliance around health & safety, site security, fire prevention and waste material monitoring. All cameras for the newly proposed solution will also have to feed directly into Hounslow's existing ARC Control Station.

2. Scope, Aims & Objectives

2.1 Scope

The scope of the agreement will centre on the agreed supplier offering a suitable digital CCTV solution and other complementary technologies at the sites as part of an agreed contract. The agreement will cover equipment supply, installation, repair and maintenance across all specified locations.





2.1 Aims & Objectives

The proposed solutions must be able to provide a modern, scalable digital CCTV system able to provide high quality coverage within and around busy operational waste sites. The solution must be able to provide the following core requirements below.

Core Requirements - All sites

- Coverage of all the required areas identified at each of the 4 sites
- High quality digital site monitoring 24 hours a day
- Secure remote online access to live feeds/recordings for designated staff
- · ANPR cameras at required locations on site
- Thermal cameras at designated locations
- Annual maintenance and support options

In addition to all core requirements outlined above, the following items are site specific -

Abbey Road

- Data storage solution housed at Abbey Road
- Cameras from Transport Avenue & Victoria Road to feed into Abbey Road site
- Remote monitoring/access service during non-operational hours
- Storage and backup for minimum 60 days

Transport Avenue & Victoria Road

CCTV & ANPR coverage of access roads leading to site

Space Waye

All on site cameras to feed into existing ARC control Station

3. Contract Milestones and Duration

The length of contract with WLWA shall be an initial term of 1 year with the option to extend for a further 12 months, and then the option to extend after this period by another 12 months, for a maximum of 3 years.

The proposed solution needs to be installed and running by the **first stage completion** date of Friday **4**th **March 2022**.

The period up until the **final stage completion** date of **Friday 18th March 2022** will be used for training, commissioning and attending to any outstanding issues or site-specific adjustments.



4. System Specifications & Requirements

4.1 Site Requirements

- Coverage of all required areas indicated above HRRC, WTS, waste material bays, weighbridge, car park, access road and front entrance gates
- Secure data storage solution on site and consumables e.g. monitors, hard drives, cabling, cabinets etc
- Remote monitoring and secure remote access
- Thermal cameras (fire detection)
- Site intrusion detection
- Annual maintenance & support options including out of hours monitoring

Transport Avenue WTS - Transport Avenue, Brentford, TW8 9HF



- Coverage (CCTV & ANPR) of access road leading up to site entrance
- Annual maintenance & support





Victoria Road WTS - Civic Way, off Victoria Road, Ruislip, HA4 0YS



- Coverage (CCTV & ANPR) of access road leading up to site entrance
- Annual maintenance & support

Space Waye HRRC - Pier Road, North Feltham Trading Estate, Feltham TW14 0TH







- Site wide coverage as required
- Monitoring on site and remotely via Hounslow's ARC Control Station
- Secure lockable storage on site unit and consumables e.g. monitors, hard drives, cabling, cabinets etc
- Site intrusion detection
- ANPR cameras/system at public & trade main gates
- Thermal cameras (fire detection)
- Annual maintenance & support

5. Quality Criteria & Method Statements

Each proposal must meet all the items listed as **essential criteria** under each of the four categories to achieve a pass during evaluation scoring. Any items listed as **non-essential criteria** will not be scored but will be taken into consideration as part of the overall bid. In your tender bid, please confirm and provide evidence where appropriate, that your product/service is able to meet these.

Site Coverage

Essential Criteria

- Coverage of all identified areas for each specified location
- High quality digital streams cameras must be able to provide quality streams day and night
- Site intrusion detection particularly during non-working hours
- Fire detection for material recycling bays e.g. plastic, garden, cardboard etc.
- Scalable system must be capable of adding more cameras and sites
- Vehicle license plate recognition applicable to all sites
- Vehicle tipping monitoring to monitor and identify where and how waste is deposited on site
- Equipment suitability to varying conditions dust, cold, heat, moisture etc.

Non-Essential Criteria

Access & Integration

Essential Criteria

- Multi-device remote access and monitoring e.g. mobile phones or tablets
- Remote monitoring service during non-operational hours generally between 16:00 hrs to 06:00 hrs seven days a week (Abbey Road, Transport Ave and Victoria Road only).
- External system integration e.g. location specific booking and weighbridge systems
- Data to be downloadable to external storage media
- Integration with LBH ARC Control Station (Space Waye only)

Ancillary Services

Essential Criteria

- ANPR (Automatic Number Plate Recognition) to include all hardware and software necessary to operate the system at all locations
- Thermal cameras & fire detection system (Abbey Road and Space Waye only)
- Data storage and backup (Abbey Road only)
- Signage includes all necessary signs to warn the public about recording

Non-Essential Criteria

- System analytics this could include incident logs or false alarms notifications
- Site access control services e.g. keypads, fobs etc.
- Other security services e.g. security gates, alarms, lighting etc.

Maintenance & Support

Essential Criteria

- Maintenance schedule recommended frequency to be based on conditions, site and necessity
- System support and training
- Remote monitoring (excluding Space Waye)
- Incident response service emergency services and dedicated staff depending on need (excluding Space Waye)
- In warranty & out of warranty support options
- Highlight all certifications and accreditations relevant to the supply, installation, monitoring and incident response for all CCTV and accompanying services
